

## PUBLIC NOTICE

**TAKE NOTICE** the Passaic County Board of Social Services has scheduled its regular Monthly Meeting for: **Thursday, August 18, 2022 at 8:30AM (EST)**. Pursuant to the State of Emergency and Public Health Emergency declared by New Jersey Governor Philip Murphy set forth in Executive Order No.: 103, and further limitations on public gatherings set forth in Executive Order No.: 104, the Board shall hold its regular Meeting at 8:30AM, as scheduled, with no members of the public physically present, as authorized under N.J.S.A. 10:4-12(a), and in accordance with Administrative Order No. 20-01 issued by the Passaic County Administrator closing County Buildings to non-essential personnel and the public effective March 18, 2020 at 8:30AM. If a member of the public wishes to place a public comment on the record, please send an email to: **info@PCBSS.org**, stating your name, address, and matter to be addressed by the Board, by no later than **August 18, 2022 at 7:00AM (EST)**. Then, the Clerk to the Board shall read same into the public record, during the public meeting. Moreover, some or all members of the Board and all members of the Public may participate in this meeting telephonically, pursuant to N.J.S.A. 10:4-12-1, et seq., and Official action may be taken. The Board Meeting for this month will be held in two (2) separate formats via the Zoom platform. The first is via Zoom live video, with the call-in information of: **https://us02web.zoom.us/j/83900962101** with **meeting ID: 839 0096 2101 and passcode: 443401**. The second will be a call-in telephone number connected to the Zoom platform: **1-888-475-4499, with meeting ID: 839 0096 2101 and passcode: 443401**. The public will also have an opportunity to speak during the "public portion of this meeting," through both the Zoom live stream platform and the Zoom telephonic platform - as authorized by law.

If an Executive session is required, the Board will retire to a closed session- pursuant to N.J.S.A. 10:4-6, and follow the procedures provided in this statute.

**ALSO**, pursuant to the issuance of Executive Order 107, this meeting will be conducted using communications equipment (i.e.: telephonic or internet streaming), which will be in compliance with N.J.S.A. 10:4-6 (the "Open Public Meetings Act"). This is also consistent with P.L. A-3855/S-2294, which was signed into law by Governor Murphy on Friday, March 20, 2020, directing that public meetings be conducted virtually during this pandemic, as well as recent Executive Orders by Governor Murphy numbered: 194 (11/10/20), 195 (11/12/20), and 196 (11/16/20).
