TAKE NOTICE the Passaic County Board of Social Services has scheduled its regular Monthly Meeting for: **THURSDAY, AUGUST 22, 2024 at 9:00 AM (EST)**. Pursuant to New Jersey Governor Philip Murphy's Executive Order Nos.: 103 and 104, the Board shall hold its regular Monthly Meeting at 9:00AM, as scheduled, with no members of the public physically present, as authorized under N.J.S.A. 10:4-12, et seq. If a member of the public wishes to place a public comment on the record, please send an email to: **info@PCBSS.org**, stating your name, address, and matter to be addressed by the Board, no later than **AUGUST 22, 2024 at 7:00AM (EST)**. Then, the Clerk to the Board shall read same into the public record, during the public meeting. Moreover, some or all members of the Board and all members of the public may participate in this meeting telephonically, pursuant to N.J.S.A. 10:4-1, et seq., and official action may be taken. The Board Meeting for this month will be held in two (2) separate formats via the Zoom platform. The first is via Zoom live video, with the call-in information of: **https://us02web.zoom.us/j/81905134199** with **meeting ID: 819 0513 4199 and passcode:279760**. The second will be a call-in telephone number connected to the Zoom platform: **1-888-475-4499, with meeting ID: 819 0513 4199 and passcode:279760**. The public will also have an opportunity to speak during the "public portion of this meeting," through both the Zoom live stream platform and the Zoom telephonic platform - as authorized by law. If an Executive session is required, the Board will retire to a closed session- pursuant to N.J.S.A. 10:4-6 ("Open Public Meetings Act"), and follow the procedures provided in this statute and N.J.A.C. 5:39-1-6.

ALSO, pursuant to the issuance of Executive Order No.: 107, this meeting will be conducted using communications equipment (i.e.: telephonic or internet streaming), which will be in compliance with N.J.S.A. 10:4-6 ("Open Public Meetings Act"). This is also consistent with P.L. A-3855 /S-2294, which was signed into law by Governor Murphy on March 20, 2020, allowing all public meetings to be conducted virtually as well as Governor Murphy's Executive Order Nos.: 194 (11/10/20), 195 (11/12/20), and 196 (11/16/20).

IN ADDITION, the within Notice has been posted at two (2) locations, namely: the Main office of the PCBSS, 80 Hamilton Street, Paterson, NJ; and the Passaic County Administrative Building, 401 Grand Street, First Floor, Paterson, NJ. The within Notice has also been forwarded to Louis Imhof, III, Clerk to the Passaic County Board of Commissioners, 401 Grand Street, 2nd Floor, Paterson, NJ to advise the Honorable Board of Commissioners of this meeting, and to Matthew Jordan, Esq., Passaic County Administrator, for notice to the County of Passaic.

LASTLY, the within Notice will be published in the official newspapers for the PCBSS, The Record and Herald News, which further complies with the Publication Rule for public meetings.

Based upon all of the foregoing, it is respectfully submitted that the PCBSS has complied with its obligations for Public Notice, pursuant to New Jersey's Open Public Meeting Act.
